# **Decorah UU Annual Meeting**

Sunday, May 1, 2022 The Lingonberry

- Brief Service (with members of the Board of Trustees) 19 attendees, including 4 guests (12 members in person + 3 guests + Otter; 2 members on-line + 1 guest) 14 members present + 4 guests + Otter.
- 2. Call to Order After the short service, Julie Ohde, Board Chair, called the meeting to order at 10:39 a.m.
- 3. Approval of 2021 Minutes Carolyn Corbin moved and Nancy Barry seconded to approve the previous year's annual meeting minutes. Julie Ohde opened the floor for discussion of the minutes. There was no discussion. The motion carried.

  - a) 2021-2022 Annual Financial Report Beth noted that the Decorah UU checking account has a very large balance right now because there are extra funds present that are transitioning to longer-term investment. Beth consulted with Carl Peterson and Shawn Dettman about this process to improve the return on these funds, which are headed into two socially responsible accounts. Meeting attendees briefly discussed the process and the various Decorah UU funds and their restrictions. Carolyn Corbin moved and Karen Esterl seconded that the Financial Report be acknowledged. The motion carried.
  - b) 2022-2023 Draft Budget Beth noted that revenue has been down a little. There is a salary increase anticipated for Otter.
